Pass Details

The Flex Pass includes all green, cart fees, and taxes for the selected months.

The “Flex Value” Pass is a single membership that allows access to only the single Designated Member listed above. The “Flex Premium” Pass includes the Designated Member, Spouse, & and Children under the age of 23, sharing the same residence.

The Flex Pass includes unlimited access to the following courses during the designated Club Member windows. The below are considered the official “Flex Pass Windows” that allow unlimited access to all Flex Pass-Holders:

Dolphin Head Golf Club: Tuesday, Thursday, Saturday: Open-12pm

Palmetto Hall Golf & Country Club: 7-Days a week, Open-11am (Designated Member Course Only, alternates daily)

All other reservations outside of the above windows can only be made within 24 hours via phone, online, or in person reservation. Tee times, course access, and practice facility access are subject to availability. Pass selection in any of the below designated “Premium Months” will require an additional reciprocal fee if played outside of the “Flex Pass Windows”. The Premium Months shall be defined as “March, April, May, September, October, November”. Any play on course, outside of “Flex Member Windows” shall be subject to a \$39 reciprocal fee, per player, for any round played. Additionally, Flex Members may not be considered or be subject to special rates provided to a certified Member’s Guest during the 2021 calendar year.

Payment of Pass & Incidentals

All Flex Passes must be paid in full, in advance. Applicant agrees to pay the account when due. All incidental charges (Guest Fees, F&B Charges, Merchandise Sales) must be paid at the time of service. Flex Pass Holders do not have charging privileges and can pay via credit*, debit, or cash. Applicant agrees to pay all reasonable attorney’s fees, investigator fees, and costs in the event any amount is turned over for collection.

All Flex Pass charges shall be charged against the card listed below under “Credit/Debit Card Payment Authorization” before 1st day of access.
